FTC Safeguards: Are you defensible?

Hi, I'm reaching out as a friendly reminder about the new Safeguards requirement that may affect your business. Last year, the FTC's Gramm-Leach Bliley Act (GLBA) went into effect.

Financial institutions, or any company that engages in significant financial activities, are now required to develop, implement, and maintain a comprehensive information security program to protect the security of their customers' financial information.

Amongst others, requirements include:

- Perform a written risk assessment
- Identify and manage assets (including data, personnel, devices, systems, and facilities)
- Establish multi-factor authentication
- Continuously monitor the system or perform an annual penetration test and biannual vulnerability assessment
- · Establish a security awareness training program
- Establish a written Incident Response Plan

- 9. Regularly report and document progress
